ORDERS & ITEMS

Stock subject to prior sale.

Priced for immediate shipment, delayed shipments may incur storage fees.

\$100 Minimum Order (through 12/31/2024).

\$250 Minimum Order Effective 1/1/2025.

Cable quoted at longest possible lengths and is subject to variation of quantity +/- 10% unless stated otherwise.

All quotes are estimates only, are subject to change without notice.

Changes in customer order requirements are subject to additional reel fees and processing fees.

PACKAGING & SHIPPING

Packaging is to ASTM D3951 – Standard Practice for Commercial Packaging unless stated otherwise.

Quoted FOB Origin, Collect Shipping unless stated otherwise.

Drop Shipping is only available in the continental United States.

Drop Ship Fees:

\$25 Fee for orders under \$500

\$50 Fee for orders \$500 or more

Prepaid & Charge Shipping estimates are not included in quote and will be determined at the time of shipment.

All prepaid and charged shipping requires insurance. MBE is not responsible for lost and or damaged product on shipments where insurance is excluded (Prepaid & Charge, Collect or Third Party). Customer takes full responsibility for lost and or damaged product on any shipments where insurance is excluded.

PAYMENT

Unless already approved by MBE for Trade Credit Terms, all quotes assume payment in full at the time of your order via USD check drawn on a US

Bank or ACH. If paying by check, orders cannot be processed until the check is received and cleared, which can take up to 5 business days from the date of deposit.

Customers may expedite orders by requesting that MBE arrange other forms of electronic payment. MBE may charge an additional administrative fee for staff to assist you in the expedited processing of your order.

Accounts must be in good standing at the placement of purchase order, otherwise a 50% deposit may apply.

TAXES AND FEES

Murray Benjamin Electric Company LLC is a wholesaler of military products. MBE's intent is to conduct business with resellers and government entities. It is the customer's responsibility to provide MBE with applicable resale or tax-exempt certificates.

MBE does not conduct business with end users where sales tax would be applicable.

It is the customer's responsibility to advise MBE if it does not meet the requirements to be exempt from sales tax and to make alternative arrangements. Failure to do so may result in the customer being responsible for remitting applicable sales and use taxes.

It is Murray Benjamin Electric Company LLC's policy to conduct business with all applicable export laws and regulations. Prices do not include taxes/duties/additional documentation applicable for deliveries outside the United States. It is the customer's responsibility to file and remit documentation, taxes and duties related to the export of goods. Any additional incurred costs will be added to the invoice at the time of shipment. Purchaser understands, agrees and accepts responsibility to comply with all US Export rules and regulations.
